The EMS Agency Medical Director provides medical control and assures medical accountability throughout the regional EMS system, pursuant to the California Health & Safety Code, Section 1797 et. Seq. and the California Code of Regulations, Title 22, Division 9 et. Seq. This is an administrative contract position.

## THE IDEAL CANDIDATE

MVEMSA is seeking a dynamic, progressive and motivated leader to direct the clinical activities of the 4 county EMS region. The ideal candidate will have background in emergency medical services administration with strong analytical, written and oral communications skills and will:

- Seek clinical opportunities to improve the status quo
- Possess knowledge and understanding of the State of California Emergency Medical Services administration and legislation
- Have the ability to oversee diverse EMS systems consisting of urban, rural and wilderness populations and geography
- Provide medical oversight of the regional quality improvement program.
- Work cooperatively with physicians, paramedics, nurses, fire fighters, law enforcement agencies, and community groups on clinical issues related to EMS system development
- Provide access as the EMS Medical Director at regional QI meetings
- Candidly address field provider performance issues
- Demonstrate strong teamwork and collaboration skills as well as evidence-based clinical decision making

#### **MINIMUM QUALIFICATIONS**

License: Current active and valid licensure as a Physician in the State of California; AND Current certification by the American Board of Emergency Medicine

Experience: At least two years experience in the practice of emergency medicine. Direct EMS experience is desirable.

#### **COMPENSATION**

The EMS Agency Medical Director is an independent contractor position. The \$48,000 annual compensation is based upon approximately 20 working hours/month with an anticipation that half of those hours, as arranged by the contractor, will be spent onsite at the Agency's offices or in meetings representing the Agency.
