## J. Calaveras RFP Update

Mr. Doyle reported that due to activities in the COVID-19 response, the RFP was resubmitted with an updated timeline to the EMS Authority for approval. The Agency plans to release the RFP today or tomorrow. The new agreement will begin on April 1, 2021, which will require an additional contract extension for American Legion Ambulance.

#### K. COVID-19 Response

Mr. Doyle stated the Agency continued to support all five member counties through the MHOAC duties. The Agency formed a COVID Task Force in three of the counties that would be able to perform testing and/or provide back-up staffing for Skilled Nursing Facilities in case of impending evacuation or shut down because of unavailable staff. The Agency began refocusing on normal operations which had previously been scaled back to core functions. All meetings are still virtual at this time. The Stanislaus County Public Health Officer guidance will be reviewed regarding the resumption of in-person meetings. None of the Agency employees have been ill with the virus.
