### A. Call to Order

Mr. Morton reminded the Board that Dr. Kann is moving on from the Agency Medical Director position. Six candidates responded to the recruitment action and one later dropped out. The remaining five candidates were interviewed last week. An offer has been made to the number one candidate.

Ms. Watson reported that candidate is having her attorney review the agreement and is hopeful to return it to us with her signature by the end of the day today.

Supervisor Tofanelli shared that Dr. Freeman was selected and has a great deal of experience in EMS. She is from Sonora and is familiar with EMS in the mountain counties. The field of candidates were all very qualified and it was a difficult decision narrowing it down to the top two.
